

RELEASE AND WAIVER OF LIABILITY

IMPORTANT: Each volunteer must sign the “Release and Waiver of Liability” before working at any facility operated by the Boys & Girls Clubs of Metro Atlanta. This includes stand-alone Clubs and extension sites. Read this waiver carefully before you sign.

RELEASE AND WAIVER OF LIABILITY

This Release and Waiver of Liability (the “Release”) executed on this _____ day of _____, 20_____, by _____ in favor of BOYS & GIRLS CLUBS OF METRO ATLANTA, a nonprofit corporation organized and existing under the laws of the State of Georgia, USA, its directors, officers, employees, agents, successors and assigns and BOYS & GIRLS CLUBS OF AMERICA in Atlanta, GA its directors, officers, employees, agents, successors and assigns (collectively, “BGC”).

The individual desires to volunteer for BGC and engage in the activities related to being a volunteer (the “Activities”). I, the volunteer hereby freely and voluntarily, without duress, execute this Release under the following terms:

Waiver and Release. I, the volunteer release and forever discharge and hold harmless BGC from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from my Activities with BGC. I, the volunteer understand and acknowledge that this Release discharges BGC from any liability or claim that volunteer may have against BGC with respect to bodily injury, personal injury, illness, death, or property damage that may result from my Activities with BGC, whether caused by the negligence of BGC or otherwise. It is also understood that BGC does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health or disability insurance in the event of injury, illness, death or property damage.

Insurance. I, the volunteer understand that, except as otherwise agreed to by BGC in writing, BGC does not carry or maintain health, medical, or disability insurance coverage for any volunteer. I expressly waive any such claim for compensation or liability on the part of BGC in the event of such injury or medical expense.

Medical Treatment. I, the volunteer hereby release and forever discharge BGC from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with my Activities with BGC.

Assumption of Risk. I, the volunteer understand that the time with BGC may include activities that may be hazardous to me including, but not limited to, physical activities, clean-up activities, renovation or general facility repair activities, loading/unloading and use of heavy equipment and materials. As the volunteer, I hereby expressly assume the risk of injury or harm in these activities and release BGC from all liability for injury, illness, death or property damage resulting from these activities and from my Activities with Boys & Girls Clubs of Metro Atlanta. I further acknowledge that I will adhere to all instructions given to me by BGC.

Background Investigation. I, the volunteer understand that a background investigation is required for all potential volunteers before any Activities can commence. Also, I the volunteer further understand that BGC reserves the right to perform periodic on-going background investigations should my Activities continue for an extended period of time. BGC will take necessary action based on the information obtained.

Photographic Release. As the volunteer, I grant and convey unto BGC all right, title, and interest in any and all photographic images and video or audio recordings made by BGC during my Activities with BGC, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

Other. As the volunteer I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Georgia in the United States of America, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Georgia. I agree that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release, which shall continue to be enforceable.
